## **PGY2 Infectious Diseases Pharmacy Residency**





#### **Program Overview**

The purpose of this PGY2 pharmacy residency program is to build upon Doctor of Pharmacy (PharmD) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.

The Infectious Disease Residency Program (PGY2) is a 12-month program located at the M Health Fairview University of Minnesota Medical Center in Minneapolis, Minnesota. We recruit for two residency positions. This program prepares the residents to become a professional infectious diseases pharmacist through a broad range of learning experiences in advanced areas of infectious diseases and antimicrobial stewardship.

We provide care for a wide range of specialties including, medicine, critical care, transplant-both solid organ and stem cell, and pediatrics.
